

Get To Know Your Classmates

What have your classmates been doing and thinking since graduation? As in past newsletters below are profiles of three classmates. All have signed on to serve as House Reps for our 45th Reunion---thanks **Joan, Susan and Mary Ann!**

Joan Gottschall



- ♦ Home: I moved to Chicago after law school, expecting to spend 2-3 years at a large law firm before returning to the New Jersey firm where I had worked both summers during law school. Shortly after I moved to Chicago, my parents moved from New Jersey to Canada, and suddenly I had no home to go to. I considered returning to New Jersey many times in the years that followed but, ultimately, came to realize that Chicago had become my home.
- ♦ Family Status: Single, never married, no kids.
- ♦ Occupation: For six months after graduating from college, I looked for a job with long-term potential. Finding nothing, I went to law school; I have been in the legal profession ever since. I have worked at a large commercial law firm, as a federal public defender, as an in-house lawyer at a university, as a federal magistrate judge and finally, in 1996, I became a United States District Court Judge. I held this position until I took "senior status" (semi-retirement) in 2012.
- Activities: Except for membership on a number of not-for-profit boards, I didn't do much outside of work until, in 2000, I bought my first house, acquired a small amount of land and took up gardening; this is probably the first real hobby I have ever had (as well as the ultimate triumph of hope over experience). I like to cook, have sung in a local community chorus and have taken a number of courses, trying to augment my meager science/math background. I am currently enrolled in a Master of Liberal Arts program, taking a mix of science and humanities courses. Keeping mentally engaged, planting things in the dirt and listening to music (my greatest debt to Smith is probably the introductory music course I took as a freshman, which I think was called Music 13) are the best ways I've found to keep negative feelings, which my job and the state of the world might otherwise inspire, at bay.
- ♦ Thoughts on Reunions: I've never come to a Reunion before because, frankly, I was terrified. My college years were very difficult years for me and each time I've thought of attending a Reunion, I find myself back in that very unhappy mental place. I went to college wanting desperately to be an academic (English literature) but lost most of my intellectual self-confidence in the summer before I started college. When I got to Smith, I found the critical approach of the English courses I took off-putting and inhospitable, and I did not have the confidence to chart my own direction. Well before I graduated from Smith, I knew that I would never be able to pursue the career which had previously been my dream. Besides that, the transition from a coed public high school to an all-women's college was very hard for me. At this point, my advancing years have led me to the conclusion that if not now, WHEN?? I'm anxious to renew old friendships and make new friends. When I signed up as a Class Rep, what went through my mind (besides the shock of being asked) was that doing so would make it really hard to chicken out from Reunion. Hope to see you all soon!

- ♦ <u>SENIOR HOUSE/MAJOR:</u> Talbot/History
- ♦ HOME: Right now, I am in Saugerties, NY, where my husband and I have lived since 1996. Before that I lived in Woodstock, NY, with my ex, and NYC (the Village). Between graduation and NYC, I bounced around a bit-Cambridge, MA, and a few places in NJ. We are about to move to Coxsackie, NY, two Thruway stops closer to my job, which means I can give up my weekday apartment near my job and live in the same house every day with my husband.
- ♦ FAMILY STATUS: I am married to Barry Braker, who has two grown children, both married, and we have a grand-daughter, who will start 1st grade this fall. I was never able to have children, so I am really enjoying this.
- OCCUPATION: I have had three careers (along the way earning masters degrees in history and teaching ESL): copyeditor, teacher of English to international students at SUNY New Paltz, and curator. I have worked at a couple of historic house museums, and since 2006 have been the curator at the NYS Bureau of Historic Sites, where I work as a consultant with all of the NYS-owned historic house museums. It's impossible to know everything about every period of U.S. history and every genre of fine and decorative arts, so I am constantly learning, and I love that. The Bureau is located on a small island (the rest all state park) in the mouth of the Mohawk River, where it flows into the Hudson, and I love that, too. Along with the curatorial unit, the facility houses the collections management (registrars), conservation, interpretation, and exhibit units. My colleagues are marvelous, which is great, because we work collegially on various projects for our sites. Collections management keeps track of all NYS-owned collections objects, the conservators treat the objects, interpretation designs and creates exhibit panels and interpretive signage, and the exhibit unit designs and builds the exhibit "furniture." I write exhibit text and furnishing plans, supervise four seamstresses who make reproduction period clothing for sites that request it, advise on furnishings--everything from the appropriate repro 18th-century wallpaper to what should be on a Gilded-Age dinner table--and field all sorts of questions from site staff.
- ♦ <u>ACTIVITIES:</u> I have served on the board of the Saugerties Historical Society and the town Historic Preservation Commission. In Waterford, I am on the board of the Waterford Historical Museum. What I truly enjoy is reading, hiking, and bird watching. I haven't done much of the latter two, but once we are moved and settled, I hope to get back to them. I also hope to make time to play my recorder and harpsichord. My husband plays guitar and wants to learn to play the bass clarinet. We both love music and hope to go to lots of concerts. Oh--I want to go kayaking; all I need is a kayak and access to water!
- ♦ THOUGHTS ON REUNIONS: I missed our first (5th) Reunion but have been to every one since. I find them very nurturing and always leave feeling very glad that I attended. I like reconnecting with former classmates and Northampton but have a stronger reason right now: my niece is class of 2016, majoring in ecological geosciences and marine biology. I helped her settle in to Albright with my sister and attended family weekend as well, where I saw the tail end of a quidditch match. Smith students have wonderful opportunities now that weren't available to us, and although I'm sorry to see the consolidation of dining services, I applaud all the support that Smith students have available to them for learning and for preparing for chosen careers.
