#### Member Profile—Ann Alton '67

My favorite question to a job applicant is this: Tell me the five things that are not on your resume but are important to understanding who you are.

Who am I? I am a mother, judge, law professor, trial lawyer, widow, daughter, sister, and aunt. My life has been full of joy and sorrow, victory and defeat. My first-born child, Matthew, died in my arms from respiratory distress. My only living child, Brady M. Alton Freeman, is my most important accomplishment. My first marriage failed because we focused on our careers rather than our marriage. My second husband, Jerry Freeman, was the love of my life. He was a trial lawyer, a former detective, an alcoholic, and a charming rogue. He died of cancer in the arms of Brady and me after 25 years of marriage and 30 years of sobriety.

I grew up on the prairie in Pipestone, in southwest Minnesota, oldest of five, and attended public school.

We moved to Lake Minnetonka in 1962 just before my senior year in high school. Three things helped route the course of my life that fall.

- Our realtor arranged for me to attend a party with the Mound Seniors.
- A college counselor suggested I consider the Ivies.
- I attended a Smith Club tea for prospective students. I fell on ice in the parking lot. My Smithie greeter looked at me, then gave me bandaids and pantyhose from her purse. Her calm common sense was the best recommendation for Smith Col-

My first view of Smith was the Quad. A taxi dropped me, alone, at the front door of Jordan House. I was scared and excited about the adventure ahead. I made my closest life-long women friends at Smith, especially in Jordan. At my first orientation lecture freshman year in 1963, President Mendenhall said two memorable things: "You are all used to being the Queen Bee. Look around and you will see 625 other Queen Bees" and "A Smith diploma is only a means to an end. To earn it, you must use your degree to make

My great grandmother Alton told me I can do anything I want to do, and Smith helped me believe it.

I graduated from the University of Minnesota Law School in June 1970. I went to work for the Hennepin County Attorneys as a law clerk right after the Bar exam and set out to get into the Adult

Criminal Division to prosecute felony cases. Juries in 1970 did not like women lawyers, but colleagues in the office helped by sending me to court day after day to question witnesses and argue



motions. On Friday, Oct 16, 1970, I was sworn in to the Bar in Minnesota: on Monday, Oct 19, I selected a jury in my very first felony trial. A woman on that jury panel said "That young woman can't possibly know what she's doing." The judge excused her, sternly inquired if anyone else had a problem (silence). and I became the

first women to prosecute felony jury trials in the Hennepin County Attorney's Office.

During the next 4 years I tried more than 50 felonies, notably a lot of sex crimes and homicides. After a year off with Brady after his birth in 1984, I went into the Civil Division at the county, where I was the Senior Attorney for all of the county's labor and employment matters for 4 years. In 1989, Gov. Rudy Perpich appointed me to the 4<sup>th</sup> Judicial District court, Hennepin County bench, where I am a general jurisdiction trial court judge.

Finally, teaching law has been my avocation since 1973. I've taught at all four Minnesota law schools and other venues and have taught my father, my only brother, my brother-in-law, my husband, and my son. The pinnacle of my judicial and teaching career came in December 2010, when I presided over my son's mock jury trial in my own courtroom (see photo). The thrill is indescribable!

In conclusion, Smith taught me how to learn; law school taught me how to reason. And an aside: Smith Day was the source of most of my professional wardrobe for at least 20 years. I bought my first St. John suit and my first Ferragamo shoes, both unworn with price tags, at Smith Day. I was very well dressed without breaking the bank. I usually still find a treasure or two and do not believe I've ever missed a Smith Day.
