### Summer on the Cuyahoga

It is currently "high season" for internships; students from the eight participating SOTC schools are furiously seeking summer employment in Cleveland. As of this writing, 49 employers have posted 71 positions and 644 students have submitted 1,832 applications. For Smith students alone, 71 students have submitted 167 applications. Two (2) Smith students have been hired to-date. **Tiffany Chen '17**, will intern at KeyBank and **Veronica Oberholzer '17** will work at University School. In addition to the jobs posted on the SOTC website,

there are two "Smith-only" internship opportunities that take advantage of Praxis: one at the Ingalls Library and Archive (part of the Cleveland Museum of Art) and the other at Policy Matters Ohio, a nonprofit policy research organization. Smith's Praxis program provides sophomores and juniors with funding for an unpaid internship.

Would you like to serve as a host to one of the SOTC interns? During the summer, Smith alumnae volunteers welcome and support the Smith interns.
